Important Information Regarding Assessment and Classification of Property This may affect your 2025 property taxes.

Following is a schedule of the 2024 Boards of Appeal and Equalization or Open Book Meetings for jurisdictions in Martin County. The purpose of these meetings is to determine whether property in the jurisdiction has been properly valued and classified by the assessor. If you believe the value or classification of your property is incorrect, you or your agent should contact the assessor's office to discuss your concerns. If you disagree with the valuation or classification after discussing it with your assessor, you may appear before the local Board of Appeal and Equalization. The board will review your assessments and may make corrections as needed. Generally, you must appeal to the local board before appealing to the County Board of Appeal and Equalization. If your jurisdiction holds an open book meeting all residents automatically qualify to appear before the County Board of Appeal and Equalization.
